SUBJECT: Good Shepherd Children and Family Services formerly Catholic Charities of St. Louis, d.b.a., Catholic Services for Children and Youth (CSCY)

[Memorandum CD06-82](#), advised staff of the consolidation of several related programs within the Catholic Charities for the Archdiocese of St. Louis organization. As part of the on-going process of consolidation, the programs formerly known as Father Dunne's Old Newsboys Home, Marian Hall, Villa Maria, and Catholic Services for Children and Youth have been combined under one name: Good Shepherd for Children and Families.

Good Shepherd is licensed as both a Residential Child Care Agency (RCCA) and a Child Placing (CP) Agency. The residential programs, now referred to as Male Residential, Male Group Home, and Female Residential are licensed to provide basic core services and the specialized standards for residential treatment services [Children's Division (CD) contract levels II (moderate) and III (severe)]. The Maternity Residential program is licensed for basic core services, residential treatment, maternity care and infant, toddler, pre-school services (CD contract levels II and III, Maternity and Maternity with Infant). The addresses and phone numbers for the residential and child placing programs have not changed. They are as follows:

- Male Residential (formerly Father Dunne's Old Newsboy's Home) serves twenty-four (24) males, ages twelve (12) to twenty-one (21) years and is located at 853 Dunn Rd., St. Louis, MO, 63031. The contact person is LeeAnn Taylor at 314-837-0513;

- The Male Group Home serves eight (8) males ages sixteen (16) to twenty-one (21) years and is located at 9920 Glen Owen, St. Louis, MO 63136. The contact person is LeeAnn Taylor at 314-837-0513;
- Female Residential (formerly Marian Hall) serves twenty-four (24) females ages twelve (12) to twenty-one (21) years and is located at 1340 Partridge, St. Louis, MO, 63130. The contact person is Stacie Newberry at 314-726-3339;
- The Maternity Residential program (formerly Villa Maria) serves twelve (12) females ages twelve (12) to twenty-one (21) and is located at 2647 Ohio, St. Louis, MO 63118. The contact person is Stacie Newberry at 314-726-3339; and
- The Child Placing program provides foster and adoptive services and is located at 20 Archbishop May Dr., St. Louis, MO, 63119. The contact person is Theresa Hayner at 314-792-7400.
