SUBJECT: REVISION OF THE PROFESSIONAL FAMILY DEVELOPMENT PLAN, CD-100

DISCUSSION:

In response to the Continuous Quality Improvement Process the Professional Family Development Plan, CD-100, instructions have been revised.

The CD-100 is to be developed with the resource family within the first 30 days of licensure. This plan is to be reviewed at each quarterly visit, annually and at re-licensure when developing a new CD-100 for the renewed licensure period.

The original intent for developing the CD-100 was to streamline and make more concise the STARS Step 11 requirement.

The format of the required information has been restructured on the form and the evaluation and signature sections have been revised to accommodate the 8 times the form is to be reviewed with the family during the 2 year licensure period.
