SUBJECT: ENGAGING FATHERS AND OTHER FAMILIAL CARETAKERS

IN THE NEWBORN CRISIS ASSESSMENT PROCESS

### DISCUSSION:

The purpose of this memorandum is to inform staff revisions have been made to the Child Welfare Manual and the Newborn Crisis Assessment Tool (NCAT) to emphasize the importance of engaging with both fathers and other familial caretakers during the completion of the newborn crisis assessment process. Staff should involve fathers and/or other familial caretakers with whom the infant is going to reside and/or spend a significant amount of time with through the completion of:

- Home visits and assessments in every home the infant is going to reside and/or spend a significant amount of time
- The safety assessment and planning process
- The NCAT specific to the father and/or familial caretaker

The Description of the Newborn Crisis Assessment, CS-24B should be provided at the time of initial face to face contact with the mother, father and/or other familial caretaker. Staff should take time to answer any questions they may have about the process before proceeding.
