SUBJECT: REFERRALS TO HEAD START/EARLY HEAD START

DISCUSSION:

The purpose of this memorandum is to follow up on Memorandum CD13-34 regarding Head Start and local Children's Division collaboration. The prior memorandum and policy required CD staff to refer all children in alternative care to Head Start. Based on feedback from the field and our partners, this policy has been revised. In the future, staff are encouraged to refer children in alternative care to Head Start. The Head Start/Early Head Start Referral form (CD-200) has also been revised based on feedback from the field

As mentioned in the prior memorandum, Head Start/Early Head Start services, when accessed, can have a direct bearing on the actions Children's Division workers use in their day-to-day interactions with families. By accessing Head Start/Early Head Start programs, families can ensure their children are receiving quality child care services to help with school readiness. It will also aid in ensuring:

- Reduction in the recurrence of child maltreatment.
- Consistency in addressing risk of harm.
- Consistency in addressing families' needs for services and/or provision of services.
- Availability and accessibility of needed services.
- Engagement of parents in child care choices.
- Information to Children's Division field staff for consideration in case planning, service delivery, and goal attainment through the Family Support Team involvement.
- Diligent efforts to meet children's early educational needs.
- Assessment of mental health needs of the parent (as well as developmental and social/emotion needs of the child) and provision of mental health services.
