SUBJECT: DISPARITY AND DISPROPORTIONALITY IN CHILD WELFARE

TRAINING REQUIREMENT FOR NEW FRONTLINE STAFF

#### DISCUSSION:

The purpose of this memorandum is to introduce a new training requirement for all frontline staff entitled *Disparity and Disproportionality in Child Welfare*. This training requirement is a result of a recommendation made by the Workgroup for Racial Equity.

The workgroup, comprised of representatives from each region of the state, developed a statewide strategic plan to address equity in child welfare practice and service provision. The strategic plan includes the implementation of a statewide training curriculum to address disparity and disproportionality in the child welfare system. As recommended by the workgroup, this training course is now required for all new frontline staff within their first year of employment following completion of Child Welfare Practice Training (CWPT). This training is also required for any Children's Division frontline staff who did not complete *Racial Awareness* training during the 2011-2012 Workgroup for Racial Equity statewide initiative.
