#### DISCUSSION:

As part of the Continuous Quality Improvement process, the Children's Division has been participating with the Casey Foundation since 2016 in the <u>Promoting Resources and</u> Opportunities for Making Permanency Timely (PROMPT) workgroup.

The PROMPT workgroup was created for the purpose of researching and promoting strategies for ensuring that children reach permanency in a timely manner and have the opportunity to grow up in loving family settings without unnecessary delays in progressing through the child welfare system.

One recommendation made by the PROMPT workgroup to continue the Children's Division goal of growing a data informed workforce is the Children's Division Data Dashboard. The Data Dashboard is comprised of twelve interactive reports that focus on the Division's goal to safely reduce the need foster care and for those in care, to safely reach permanency.

The following measures are included:

# **Reduce Rate of Children Entering Care**

- Entry Rates Per Thousand
- Re-entry based on exit cohort

#### **Decrease Maltreatment Recurrence**

- Maltreatment in Foster Care
- Re-occurrence of Maltreatment

## **Improve Timely Stable Permanency**

- Permanency within 12 months for those children entering foster care
- Length of time to reunification based on exit cohort
- Length of time to adoption based on exit cohort
- Length of time between entry and filing of TPR
- Length of time between filing TPR and finalized adoption
- Length of time to guardianship based on exit cohort
- Overall length of time in care based on exit cohort
- Placement stability 2 or fewer moves in first 12 months in care
- Percent of children residing in residential placement settings

The Dashboard will be available to all staff and to the general public through the Children's Division internet site.
