You might be able to receive benefits for longer than 45 months if you are:

- Permanently disabled;
- Taking care of a disabled person who lives in your home;
- Age 60 and older;
- In an emergency situation including domestic violence;
- In treatment for substance abuse;
- In treatment for mental health;
- Active in children's division and income maintenance; or
- In a family crisis.

If one of the above apply to you and you have not told the Family Support Division (FSD), you must contact the FSD at (855) FSD-INFO or (855) 373-4636.

**Help with Employment and Training**

There is still time for you to be involved with the Missouri Work Assistance Program (MWA). The MWA program can help you with job search, job training, education and finding employment. The MWA program will help you set goals and get the skills you need to find a job and support your family.

**Family Support Division Programs**

The time limit for Temporary Assistance does not apply to other programs offered through the Family Support Division including:

- \*Health care coverage through MO HealthNet
- \*Food Stamps
- \*Child Care Subsidy
- \*Child Support services

### **Child Care Subsidy**

### **Child Support**

Because you receive Temporary Assistance, FSD will take action to establish paternity, establish and/or enforce or modify a child support order. If FSD collects current support while you are receiving Temporary Assistance, the state will keep the support paid. If FSD collects current support after you stop receiving Temporary Assistance, you will receive the current support paid.

Collecting child support could increase your family's income when your Temporary Assistance grant ends. FSD will help you collect child support - even after your Temporary Assistance ends. Help FSD help you get the support you and your children deserve.

Often, FSD cannot establish paternity or collect support without your help. You need to keep any appointments child support specialists schedule for you. You need to tell child support specialists any information you have about the other parent: where (s)he lives or works. ### **Temporary Assistance in Another State**

If you have received Temporary Assistance in another state, you must report this to the Family Support Division.
