The purpose of this memorandum is to familiarize staff with:

The Center for Excellence

The Department of Social Services has entered into a contract with the University of Missouri, School of Medicine, Department of Psychiatry for The Center for Excellence.

The Center for Excellence serves Missouri Children's Division in an oversight capacity (as noted in PA18-CM-09) and allows for ongoing monitoring and consultation to case managers and supervisors regarding behavioral health and medical needs and issues of children.

The Center for Excellence provides clinical and support staff including - Board Certified Child and Adolescent Psychiatrist, Licensed Clinical Psychologist, RN Case Manager, Psychiatric Pharmacist, Geneticist, Medical Ethicist, Pediatrician and Pediatric RN Case Manager to perform the following:

Consultation

- The Center provides consultation related to medication and/or behavioral health treatment. Examples of psychotropic medication consultation include questions related to a child being placed on medications for the first time or a change in medication, parent(s) not consenting to recommended medication(s), or a general overview of all the child's medications if there is a concern.
- Treatment (case) consultations tend to be longer term with the intention of finding a solution to better support more complex cases. This consultation may be aimed at stabilizing placement, reviewing trauma history, and identifying appropriate types of therapy.

• Physical Health Consultation

The Center provides consultation related to physical health needs. This
can include routine and specialty health issues.

Medication Reports (Secondary Reviews)

- The Center conducts ongoing reviews of children who have identified prescribing Quality Indicators (QI's). Examples of QI's – 6-17 year olds who were on 4 or more psychotropic medications for 90 or more days and 18-21 year olds who were on 5 or more psychotropic medications for 60 or more days.
- Individualized data sheets are created for each identified youth which will include information such as clinical issues for the QI, current medications, potential drug interaction, health alerts and next steps. This information will be sent directly to the case manager from the Center
- Follow-up phone consultations with RN Case Manager for youth with QI's
