**SkillUP** is a free program that helps SNAP (Missouri Food Stamp Program) participants get help with skills, training, and employer connections, to get a job (or a better job).

### How can SkillUP help?

A SkillUP job coach will work with you to create an individual plan to help you reach your goals and start a new career. The SkillUP program can also help you:

- Get skills you need through workshops and classes
- Pay for short-term training and certifications
- Pay for some daycare, work, or training costs
- Understand your job skills and what you are interested in
- Update or create your resume so employers can see your skills
- Connect you with employers
