- **SUBJECT:** FINAL ARRANGEMENTS PLANNING

DISCUSSION:

The purpose of this memo is to introduce Section 8, Chapter 9.2 (Alternative Care Child Fatality Notification and Final Arrangement Planning) of the Child Welfare Manual which outlines the process of notification, documentation and final arrangement planning following the death of a child who:

- is in the legal custody of the Children's Division
- is a child of a youth in alternative care (CYAC)
- is placed in the custody of the Division, does not leave the care of a parent and the legal status is tracked through the Family Centered Services function.

Children's Division has increased its standard contribution for final arrangements (burial, cremation, funeral home services, etc.) from \$1,500 to \$4,500. Additionally, a process has been established to seek approval of the Division Fiscal Liaison if expenses are expected to exceed \$4,500.

Form *CD-312 Final Arrangements Expense Authorization* has been developed to aid in tracking financially contributing sources along with any portion of expense for which Children's Division is responsible, and to obtain appropriate approvals.

The policy update includes:

- Actions to take following the death of a child/youth
- Process of notification
- Final arrangement planning
- Allowable expenses
- Final arrangement expense authorization and payment process
- Documentation requirements
- Staff resources and reference sources
