SUBJECT: Protective Services Child Care Subsidy Transition to DESE/Office of Childhood - Use of the *CD-317 Child Care Subsidy Verification Letter*

DISCUSSION:

The Department of Elementary and Secondary Education (DESE) Office of Childhood has administered the Child Care Subsidy program since August 2022. On December 19th 2023, DESE launched their Child Care Data System (CCDS) – Parent Portal. This portal allows eligible families to independently apply for child care assistance, report a change in their household, obtain authorizations, and select or change their child care provider.

The Child Welfare Manual has been updated to reflect the following changes:

- Protective Services Child Care Subsidy eligibility
- Protective Services Child Care Subsidy Waiver process
- Child Care Subsidy Verification Letter (CD-317) requirements
- Protective Services Child Care Subsidy application process
- Resources for Families, Child Care Providers and Workers

Authorizations Previously Entered in FACES/FAMIS

Children's Division staff no longer enter authorizations for child care.

Children's Division's access to input authorizations in FACES/FAMIS ended on December 14, 2023, to allow the previously entered authorizations in FACES to transfer to the CCDS portal. The Child Care Authorization link in FACES continues to be available for viewing of historical entry, however can no longer be accessed to input or change information.

Applications previously entered into FACES have transferred to the CCDS portal and do not require action to be taken by the family until nearing their authorization end date.

Adoption and Guardianship Subsidy

The *Explanation of Benefits for Child Care Attachment* has been created to notify all adoptive and guardianship subsidy applicants of child care eligibility and requirements. The attachment has been added to the current versions of the Adoption Subsidy and Subsidized Guardianship Agreements in E-Forms.

The *Explanation of Benefits for Child Care Attachment* must be signed and included with initial subsidy agreements.

The *Explanation of Benefits for Child Care Attachment* must be completed when submitting subsidy amendments or attachments if it has not been completed previously.

Subsidy agreements signed on or after June 1, 2025 must include an *Explanation of Benefits for Child Care Attachment*, or the agreement will be returned without being processed for approval.

The Checklist for Subsidy Agreements has been updated to remove child care from the services and explanation of services sections.
